The meeting will be held **May 16, 2019 at 14:00** at the American Embassy Lisbon. Prospective quoters must notify the Procurement by e-mail of the names of their representatives who will be attending the meeting no later than **May 14, 2019** so access to the Embassy can be arranged.

1.0 DESCRIPTION

The American Embassy in Lisbon requires annual preventative maintenance services on the Photovoltaic system installed in the American Embassy Lisbon.

1.1. TYPE OF CONTRACT

This is a firm fixed price contract payable entirely in **EUROS**. No additional sums will be payable for any escalation in the cost of materials, equipment or labor, or because of the contractor's failure to properly estimate or accurately predict the cost or difficulty of achieving the results required. The contract price will not be adjusted due to fluctuations in currency exchange rates.

1.2. PERIOD OF PERFORMANCE

The contract will be for a period of one-year, with four one-year optional periods of performance and will be expected to commence no later than July 1, 2019.

2.0 PRICING

The rates below include all costs associated with providing all required maintenance services on the Photovoltaic system in accordance with the attached scope of work, and the manufacturer's warranty including materials, labor, insurance (see FAR 52.228-4 and 52.228-5), overhead, profit and VAT. The contract will be for a one-year period, with four one-year optional periods of performance.

2.1. Base Year. The Contractor shall provide the services shown below for Base period of the contract and continuing for a period of 12 months.

3.0 NOTICE TO PROCEED

After contract award and submission of acceptable insurance certificates and copies of all applicable licenses and permits, the Contracting Officer will issue a Notice to Proceed. The Notice to Proceed will establish a date (a minimum of ten (10) days from date of contract award unless the Contractor agrees to an earlier date) on which performance shall start.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1.0 CHARACTER AND SCOPE OF WORK

The Contractor shall furnish and apply all materials required to perform annual preventive maintenance on the Photovoltaic system installed in the US Embassy Lisbon. This is a preventive maintenance. Any repair work will be addressed separately.

2.0 EXISTING CONDITIONS

The US Embassy is fully operational and functional. All work must be scheduled with the contracting officer's representative (COR).

3.0 SURVEY

The Contractor shall survey the property and verify the work required, to determine if any discrepancies exist. The Contractor shall be responsible for any errors that might have been avoided by such a survey/review. The Contractor shall immediately report any discrepancies to the COR or the Contracting Officer and shall not begin work until such matters are resolved.

4.0 PREPARATION/PROTECTION OF WORK AREA

Work shall not disturb or damage any fixed property (including cameras, light fixtures, roofs, walls or windows). The Contractor shall make every effort to protect USG property and return such property to its original position upon completion of work in that area.

5.0 UTILITIES

The Government will provide all electrical power and water necessary for the contractor to perform their work.

6.0 EQUIPMENT

The Contractor shall provide all necessary materials and equipment necessary to complete the work. The Government will not furnish any materials.

7.0 TECHNICAL SPECIFICATIONS

- 7.1 Visually inspect photovoltaic surfaces for damage, hotspots in the cells.
- 7.2 Clean all modules.
- 7.3 Inspect module frame, mechanical parts and supporting structure. Tighten screw as necessary.
- 7.4 Inspect DC junction and/or string boxes, cabling and clips, DC connectors at each connection point, trays, and wiring pathways and earth system. Include findings and the conditions in the field report.
- 7.5 Inspect and check inverters for proper operation including the electronics and cable isolation.
- 7.6 Check for power cables for overheating
- 7.7 Tighten terminal screws on all electrical connections.
- 7.8 Check alarm history.
- 7.9 Clean air filters in inverters.
- 7.10 Perform general cleaning on the inverters.
- 7.11 Visually inspect UPS systems if one is installed.
- 7.12 Visually inspect and tighten low voltage connectors and cabling
- 7.13 Check all junction boxes, inverter housing and metering devices.
- 7.14 Check the monitoring equipment including cable status, electrical boxes, data-logger, displays and front indicators for proper operation. Include findings in the field report.
- 7.15 Visually check the weather station including the reference cells including water supply.
- 7.16 Within 30 days of completing annual preventive maintenance, provide a copy of the field report to the COR.

8.0 PAYMENT

- 8.1 The Contractor shall receive payments per the basic contract. The Contractor shall issue invoices on annual basis.

8.2 The contractor must provide the completed form showing work was accepted by post, with the invoice. The invoice is to be submitted after the preventive maintenance on the Photovoltaic System has been completed.

8.3 The United State Government does not pay for services in advance.

9.0 INSPECTION BY GOVERNMENT:

The services and the supplies furnished will be inspected from time to time by the COR, or his/her authorized representatives, to determine that all work is being performed in a satisfactory manner, and that all supplies are of acceptable quality and standards.

The Contractor shall be responsible for any countermeasures or corrective action, within the scope of this contract, which may be required by the Contracting Officer as a result of such inspection.

10. QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)

This plan is designed to provide an effective surveillance method to promote effective Contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to conduct quality assurance to ensure that contract standards are achieved.

10.1 SURVEILLANCE

The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.

10.2 STANDARD

The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.246-4, Inspection of Services – Fixed Price (AUG 1996)), if any of the services exceed the standard.

10.3 PROCEDURES

(a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.

(b) The COR will complete appropriate documentation to record the complaint.

(c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.

(d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.

(e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.

(f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.

(g) The COR will consider complaints as resolved unless notified otherwise by the complainant.

(h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

11. SECURITY

General. The Government reserves the right to deny access to U.S.-owned and U.S.-operated facilities to any individual. The Government will run background checks on all

proposed Contractor employees. The Contractor shall provide the names, biographic data and police clearance on all Contractor personnel who shall work on this contract.

Identity Cards. The Government shall issue identity cards to Contractor personnel, after they are approved. Contractor personnel shall display identify card(s) on the uniform at all times while providing services under this contract. These identity cards are the property of the Government. The Contractor is responsible for their return at the end of the contract, when an employee leaves Contractor service, or at the request of the Government.

12. STANDARDS OF CONDUCT

(a) General. The Contractor shall maintain satisfactory standards of employee competency, conduct, cleanliness, appearance and integrity and shall be responsible for taking such disciplinary action with respect to employees as required. Each Contractor employee is expected to adhere to standards of conduct that reflect credit on themselves, their employer, and the United States Government. The Government reserves the right to direct the Contractor to remove an employee from the worksite for failure to comply with the standards of conduct. The Contractor shall immediately replace such an employee to maintain continuity of services at no additional cost to the Government.

(b) Uniforms. The Contractor's employees shall wear clean, neat and identifiable uniforms, although not necessarily identical uniforms. All employees shall wear accreditation at all times.

(c) Disorderly conduct, use of abusive or offensive language, quarreling, intimidation by words, actions, or fighting shall not be condoned. Also included is participation in disruptive activities that interfere with normal and efficient Government operations.

(d) Intoxicants and Narcotics. The Contractor shall not allow its employees while on duty to possess, sell, consume, or be under the influence of intoxicants, drugs or substances that produce similar effects.

(e) Criminal Actions. Contractor employees may be subject to criminal actions as allowed by law in certain circumstances. These include but are not limited to the following actions:

- falsification or unlawful concealment, removal, mutilation, or destruction of any official documents or records or concealment of material facts by willful omission from official documents or records;
- unauthorized use of Government property, theft, vandalism, or immoral conduct;

- unethical or improper use of official authority or credentials;
- security violations; or,
- organizing or participating in gambling in any form.

(f) **Key Control.** The Contractor shall receive, secure, issue and account for any keys issued for access to buildings, offices, equipment, gates, etc., for the purposes of this contract. The Contractor shall not duplicate keys without the COR's approval. Where it is determined that the Contractor or its agents have duplicated a key without permission of the COR, the Contractor shall remove the individual(s) responsible from this contract. If the Contractor has lost any such keys, the Contractor shall immediately notify the COR. In either event, the contractor shall reimburse the Government for the cost of rekeying that portion of the system.

(g) **Neglect of duties** shall not be condoned. This includes sleeping while on duty, unreasonable delays or failures to carry out assigned tasks, conducting personnel affairs during duty hours and refusing to render assistance or cooperate in upholding the integrity of the work site security.

13. PERSONNEL HEALTH REQUIREMENTS

All employees shall be in good general health without physical disabilities that would interfere with acceptable performance of their duties. All employees shall be free from communicable diseases.

14. LAWFUL OPERATION, PERMITS, AND INDEMNIFICATION

(a) **Bonds.** The Government imposes no bonding requirement on this contract. The Contractor shall provide any official bonds required, pay any fees or costs involved or related to the authorization for the equipping of any employees engaged in providing services specified under this contract if such bonds or payments are legally required by the local government or local practice.

(b) **Employee Salary Benefits.** The Contractor shall be responsible for payment of all employee wages and benefits required by host country law or agreements with its employees. The Government, its agencies, agents, and employees shall not be part of any legal action or obligation regarding these benefits which may subsequently arise. Where local law requires bonuses, specific minimum wage levels, and premium pay for holidays, payments for social security, pensions, sick or health benefits, severance payments, child care or any other benefit, the Contractor is responsible for payments of these costs and must include them in the fixed prices in this contract.

(c) **Personal Injury, Property Loss or Damage (Liability).** The Contractor assumes absolute responsibility and liability for any and all personal injuries or death and property damage or losses suffered due to negligence of the Contractor's personnel in the

performance of this contract. The Contractor's assumption of absolute liability is independent of any insurance policies.

(d) Amount of Insurance. The Contractor is required to provide whatever insurance is legally necessary. The Contractor shall, at its own expense, provide and maintain during the entire performance period the following insurance amounts:

General Liability

- (1) Bodily Injury stated in EUROS:
 - Per Occurrence
 - Cumulative €1,000,000.00

- (2) Property Damage stated in EUROS:
 - Per Occurrence €1,000,000.00
 - Cumulative €1,000,000.00

The types and amounts of insurance are the minimums required. The Contractor shall obtain any other types of insurance required by local law or that are ordinarily or customarily obtained in the location of the work. The limit of such insurance shall be as provided by law or sufficient to meet normal and customary claims.

For those Contractor employees assigned to this contract who are either United States citizens or hired in the United States or its possessions, the Contractor shall provide workers' compensation insurance in accordance with FAR 52.228-3.

The Contractor agrees that the Government shall not be responsible for personal injuries or for damages to:

- (a) any property of the Contractor,
- (b) its officers,
- (c) agents,
- (d) servants,
- (e) employees, or
- (f) any other person, arising from and incident to the Contractor's performance of this contract.

The Contractor shall hold harmless and indemnify the Government from any and all claims arising, except in the instance of gross negligence on the part of the Government.

The Contractor shall obtain adequate insurance for damage to, or theft of, materials and equipment in insurance coverage for loose transit to the site or in storage on or off the site.

(e) Permits. Without additional cost to the Government, the Contractor shall obtain all permits, licenses, and appointments required for the prosecution of work under

this contract. The Contractor shall obtain these permits, licenses, and appointments in compliance with applicable host country laws. The Contractor shall provide evidence of possession or status of application for such permits, licenses, and appointments to the Contracting Officer with its proposal. Application, justification, fees, and certifications for any licenses required by the host government are entirely the responsibility of the Contractor.

(f) Workers' Compensation and Employer's Liability

Workers' Compensation and Occupational Disease is statutory and it is required by host country law, according to Portuguese Decree Law No. 98/2009

Employer's Liability * per occurrence (see above)

15. ORDERING OFFICIAL

The designated ordering individual under FAR 52.216-18 is the Contracting Officer.

16. CERTIFICATE OF INSURANCE

The Contractor shall furnish to the Contracting Officer a current certificate of insurance as evidence of the insurance required. In addition, the Contractor shall furnish evidence of a commitment by the insurance carrier to notify the Contracting Officer in writing of any material change, expiration or cancellation of any of the insurance policies required not less than thirty (30) days before it is effective.
